#### DIRECTIONS

FOR CONTROL OF FERAL OR DOMESTIC PIGEONS IN MUNICIPALITIES AND AROUND FARM BUILDINGS DURING THE WINTER MONTHS.

### PREBAITING

PLACE UNTREATED GRAIN FOR SEVERAL DAYS IN AREAS OF PIGEON ACTIVITY PRIOR TO TO PLACEMENT OF PIGEON-9. PREBAIT SITES SHOULD BE LOCATED IN AREAS CLOSE TO BUILDINGS TO MINIMIZE THE HAZARD TO BENEFICIAL BIRDS AND OTHER WILDLIFE. SCATTER ONE TO FIVE QUARTS OF UNTREATED GRAIN ON THE BARE GROUND. PREBAITING SHOULD BE CONTINUED DAILY UNTIL UNTREATED GRAIN IS ACCEPTED READILY.

#### BAITING

PIGEON-9 SHOULD NOT BE PUT OUT UNTIL UNTREATED GRAIN HAS BEEN ENTIRELY CONSUMED OR CLEANED UP. DO NOT USE PIGEON-9 IF NON-TARGET BIRDS OR ANIMALS ARE FEEDING IN THE TREATMENT AREA.

AMOUNT OF PIGEON-9 TO BE USED WILL BE DETERMINED BY THE AMOUNT OF UNTREATED GRAIN CONSUMED DAILY. PIGEON-9 SHOULD BE SCATTERED IN THE SAME LOCATIONS AS AS THE UNTREATED GRAIN. PICK UP AND DESTROY ALL DEAD BIRDS DAILY. UNEATEN PIGEON-9 SHOULD BE PICKED UP AND DESTROYED WHEN THE DESIRED CONTROL HAS BEEN OBTAINED.



## ANTIDOTE:

If less than ten minutes has passed since the poleon was taken, give a tablespoonful of salt in a glass of warm water. Have victim lie down in a quiet, darkened room and keep him warm. Call a Physician Immediately!

## DANGER .. CONVULSIVE POISON!

Do not contaminate food and foodstuffs. Keep away from children and domestic animals. When empty, all containers and all grain fragments must be burned or buried deeply.

Where placement of strychnine-treated grain presents a hazard to wildlife or livestock, all placements must be made under existing or introduced cover of brush or woods.
