Subject: Amendment - Label Update/Solvent Substitution B and G Diazinon 4S EPA Registration No. 8612-61

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFTA), is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

- Submit/cite all data required for registration/reregistration of your product under PIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
 - a. Xylene cannot be included in the Active Ingredient section unless you have information that would support it as an active. Assuming you do not have this supporting information the xylene must be incorporated as part of the Inert Ingredient section. It should appear as follows:

INERT INGREDIENTS* 51.34
* Contains xylene range aromatic.

b. Add the sentence "DO NOT INDUCE VOHITING" to the subheading section "If Swallowed."

c. Add to the Statement Of Practical Treatment the following subheading and wording:

Note to Physicians Diskinon is an organophosphate insecticide. If symptoms of cholinesterase inhibition are present, atropine sulfate by injection is antidotal. 2-PAM is also antidotal and may be administered, but only in conjunction with atropine.

d. Revise the last sentence of the Precautionary Labeling section to read "Do not allow children or pets in treated"

Submit five (5) copies of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with PIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records.
