DIRECTIONS FOR USE

PLACE TARLA-DIPHAS IN A PROTECTED SPOT WHERE THE RATS AND MICE ORDINARILY FEED, WATER OR TRAVEL. BAIT PLACEMENTS ARE DESIRABLE ALONG WALLS, IN CORNERS, AND IN CONCEALED LOCATIONS WHERE RATS AND MICE CAN FEED UNOBSERVED. IF BAIT BECOMES SOUR OR MOLDY (AS MAY BE THE CASE DURING PERIODS OF HUMID WEATHER), REPLACE WITH FRESH BAIT AS NEEDED. FOR TYPICAL SITES, INCLUDING FARMS, HOMES, WAREHOUSES AND OUTBUILDINGS CONSULT THE SPECIFIC RAT AND MOUSE DIRECTIONS BELOW. FOR OTHER SITES, CONSULT BOTH THOSE AND OTHER SPECIAL DIRECTIONS BELOW.

FOR CONTROL OF RATS AND MICE

FOR NORWAY AND ROOF RATS: USE 1/4 TO ONE POUND PER BAIT PLACEMENT. LOOK FOR TELL-TALE SIGNS AS GNAWINGS, TRACKS OR TRAILS, BURROWS, DROPPINGS, OR DAMAGE. MAINTAIN AN UNINTERRUPTED SUPPLY OF BAIT FOR AT LEAST 10 DAYS.

FOR HOUSE MICE: PLACE TEASPOONFUL AMOUNTS (1/4 TO 1/2 OUNCE) OF BAIT AT INTERVALS OF 8 TO 12 FEET. MAINTAIN AN UNINTERRUPTED SUPPLY OF BAIT FOR AT LEAST 15 DAYS.

FOR RODENT CONTROL ON WHARFS AND BOATS

SPECIAL PRECAUTIONS MUST BE TAKEN TO KEEP RODENT BAIT DRY IN WET, HUMID USE AREAS. PLACE BAIT IN WEATHERPROOF BAIT STATION IN A DRY, PROTECTED AREA WHERE RATS AND MICE CAN FEED UNOBSERVED. CLEAN BAIT STATION AND REPLACE BAIT IF IT APPEARS MOLDY OR SOUR.

FOR USE IN DUMPS

IN AREAS SUBJECTED TO HEAVY AND REOCCURRING RODENT POPULATIONS, ESTABLISH PERMANENT BAIT STATIONS OF WEATHERPROOF CONSTRUCTION. REPLENISH WITH FRESH BAIT AS NEEDED.

"DO NOT CONTAMINATE FOODS OR FEED STUFFS." ALL PLACEMENTS MUST BE MADE IN TAMPER-PROOF BAIT BOXES.
