Dursban combination in one direction and apply the balance at right angles. Immediately after application, water turf with 30 gallons of water per 1000 sq. ft. (sufficient water to soak the top 2-3 inches of soil) so as to wash the insecticide into the zone of insect infestation. The table below indicates water needed for larger sized areas. Keep children and pets off treated areas until material is washed into the soil and grass is dry.
