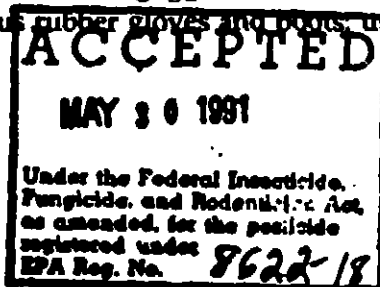
**DIRECTIONS FOR USE**

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in dark, cool, dry, well-ventilated area, not above 40°C in well-closed original containers away from energy sources, combustible organic materials, oxidizers, and moisture. When handling or dealing with spills, use impact-resistant goggles with side-shields or face shield, wear body-covering clothes including impervious rubber gloves and boots, use a dust respirator if dusting occurs.

**PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal Law.
