Subsequent Dose: When microbial control is achieved, add BIOBROM C-105L at the rate of 1.2 to 4.0 lbs. (36 to 120 ppm) per 1000 gals of feedwater as needed to maintain control or as specified by guidelines recommended by the membrane manufactures.

Initial or Slug Dose: When the system is noticeably fouled, add BIOBROM C-105L at the rate of 1.1 gais (2.65 bs) per 1000 gals of metalworking fluid in the system. Repeat until control is achieved. Subsequent Dose: When microbial control is evident, add BIOBROM C-105L at the rate of 0.4 to 0.8 gal (1.06 to 2.12 bs) per 1000 gals of metalworking fluid per day, or as needed to maintain control. Additions of BIOBROM C-105L product can be made continuously or intermittently. Slug the system as required.

For controlling slime-forming bacteria, sulfide-producing bacteria, yeasts, and fungi in oil field water, polymer or micellar floods, water-disposal systems, or other oil field water systems, add 1-80 ppm BIOBROM C-105L (0.4 - 25.6 gallons of BIOBROM C-105L per 2400 barrets of water) depending on the severity of contamination. Additions should be made with a metering pump either continuously or intermittentity.

CONTINUOUS FEED METHOD

When the system is noticeably fouled, add 10-80 ppm BIOBROM C-105L (3.2-25.6 gals. of BIOBROM C-105L per 2400 barrels of water) continuously until the desired degree of control is achieved. Subsequently, treat with 1-15 ppm BIOBROM C-105L (0.4-4.8 gals. of BIOBROM C-105L per 2400 barrels of water) continuously or as needed to maintain control. INTERMITTENT OR SLUG METHOD

Rapid mixing is necessary for maximum effectiveness. BIOBROM C-105L should be added at a location where a contact time of 10 minutes or longer will be provided before reaching the outfall.
