FOR USE ON COTTON

For control of the above-named insects attacking cotton, apply Staplcotn 8-2 Strobane-Methyl Parathion at the rate of 1 gallon to

Ground Sprayer: Use enough water for thorough and uniform coverage, and apply with 50 to 60 pounds pressure.

Aircraft Application: Use enough water for thorough and uniform coverage, but not less than 3 to 10 gals. per acre, depending

upon crop growth.
