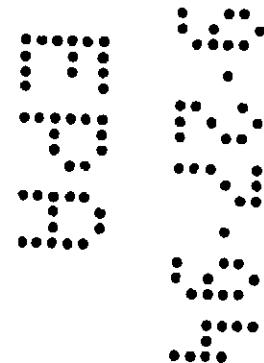

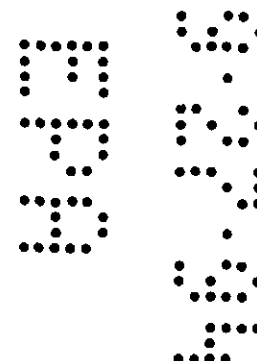

- Apply in January, February or early March to prevent germination of crabgrass, bull paspalum, sedges (from seed), and spotted spurge.
- Apply anytime broadleaf weeds are growing to get control.
- Apply in the fall to control henbit, chickweed and other winter weeds.
- If complete control is not obtained, a second application may be necessary 2 months after the first.

**USE PRECAUTIONS**

Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production, or for research purposes.

Not for use on or under trees, shrubs, bedding plants, flowers or garden plants.

- Do not apply under the branches (rootzone area) of shrubs, trees, flowers etc.
- Do not apply to newly seeded Zoysia, centipede, or carpetgrass lawns. Wait until they have required at least 2 mowing.
- Do not apply to flowers, bedding plants, ornamental trees or shrubs.

**WHAT THIS PRODUCT DOES**

STA-GREEN Crabgrass Preventer With Fertilizer controls growing weeds such as dandelion, black medic, buckhorn, burciver, Carolina Geranium, chickweed, purslane, Florida betony, Florida pusley, rabbit-tobacco, henbit, matchweed, oxalis, red sorrel, rescuegrass, shepherdspurge, wild mustard, and many others. This product also contains a high quality, slow-release fertilizer. This product will green your lawn in a few days and will continue feeding for 3-4 months.

For best results apply with a fertilizer spreader at the setting listed below. Apply to newly sprigged St. Augustine or Zoysia lawns to help prevent competition from other weeds. Apply when grass blades are dry. On hot day (above 80°) water the lawn to rinse particles off the grass.
