**CONTROLS SUCH PESTS AS:** Sod Webworms (Lawn Moth), Armyworms, Ants, Chinch Bugs, Brown Dog Ticks, Fleas, Cutworms, Chiggers, Clover Mites and Crickets.

**TIME TO APPLY:** Apply anytime after pests appear and before severe damage can be done. Water in well for best results. Use 50 lbs. on 14,500 square feet for Bahia, Bermuda, Centipede, Fescue, St. Augustine grasses and Dichondra. To help obtain uniform distribution, apply one-half the required amount of product in one direction, then apply the balance at a right angle. Immediately after application, thoroughly water the treated turf to wash the insecticide into the zone of insect infestation.
