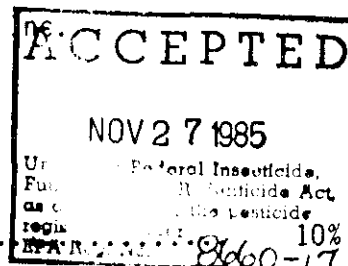

This fertilizer + Ronstar product is a selective, preeemergent herbicide that controls many annual grasses and broadleaf weeds in turf grasses growing on golf courses, lawns and other ornamental and recreational turf areas. Read this entire label before using.

When used as directed this product will give PREEMERGENCE CONTROL OF GOOSEGRASS, CRABGRASS, ANNUAL BLUEGRASS (POA ANNUA), FLORIDA PUSLEY, OXALIS, STINGING NETTLE, CARPETGRASS AND PIGWEED in established perennial bluegrass, bermudagrass, perennial ryegrass, St. Augustinegrass, tall fescue and zoysia, plus provide an application of fertilizer.

FOR CONTROL OF GOOSEGRASS, CRABGRASS and other spring germinating weeds, apply in the late winter/early spring prior to weed seed germination at 250 lbs per acre (provides 2.5 lbs of Ronstar per acre). Optimum weed prevention will result if treated areas are irrigated soon after application.

FOR CONTROL OF POA ANNUA (annual bluegrass) apply in the late summer/early fall prior to weed seed germination at 250 lbs per acre (provides 2.5 lbs of Ronstar per acre). Optimum weed prevention will result if treated areas are irrigated soon after application.

REMINDER

Be sure to apply this product prior to weed seed germination; otherwise, the application may not be fully effective. This product does not control established weeds.

Rake turf area free of leaves, mowing if necessary, so product granules will reach the soil surface.

Complete any cultural practices that disturb the soil (e.g. aerifying, verti-cutting) before the application. Disturbing the soil surface after the application will reduce effectiveness.

Do not apply to red fescue, bentgrass, centipedegrass or Dichondra.
