## RATES, REQUENCY AND TIMING OF APPLICATION

Successful preemergence control of the annual grass weeds listed on this label requires proper timing of application.

Apply to prevent crabgrass and other annual weeds in the Spring at the NORMAL rate one to two weeks before germination (before dandelions reach the puffball stage).

Apply in August or September to prevent germination of Poa annua. Apply at the NORMAL rate on cool season grasses (fescue, bluegrass, etc.) and at the HEAVY rate on warm season grasses (bermuda, zoysia, centipede, St. Augustine, Bahia, etc.).

Do not aerify, rake, verticut or otherwise disturb the soil after application. This can disturb the chemical barrier on the soil surface.

Do not reseed for 12 to 16 weeks after application as the preemergence herbicide will also prevent grass seed from germinating.

Do not apply to newly sprigged areas of bermudagrass, St. Augustinegrass, centipedegrass or zoysiagrass until these turfs are well established. Do not apply to dichondra.

Always apply product evenly over the turfgrass area with a spreader. Never apply by hand.
