The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable provided that you:

1. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:

a. Since this product is only sold in 1 lb containers and is for use in toilet bowls, delete the Storage and Disposal Section: "FOR PROFESSIONAL/COMMERCIAL USE ONLY".

b. Delete: "CONTAINER DISPOSAL; Do not reuse bag. Discard bag in trash." These statements are redundant.


c. In the warranty statement delete: "weather and crop conditions". This product is used indoors.

d. Delete "Buyer assumes all risks of use, storage or handling of this product." This statement detracts from the labeling information required under FIFRA. Refer to the enclosed November 16, 1966 PR Notice.

2. Submit one (1) copy of your final printed labeling before you release the product for shipment.

A stamped copy of the labeling is enclosed for your records.
