The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable provided that you:

1. Make the following changes to your label:

a) In the Environmental Hazards statement change "wetlands" to "areas where surface water is present or to intertidal areas below the mean high water mark."

b) Add a Statement of Practical Treatment for inhalation to the label.

c) Delete the Storage and Disposal statement for professional/commercial use since this product is labeled for homeowner use only.

d) In the Directions for Use on ASPARAGUS, change "...3 days" to "...7 days."

e) In the Directions for Use on CATS AND DOGS, in the paragraph beginning <u>For Ticks and Fleas</u>, delete the sentence "Avoid treatment of kittens or puppies less than 4 months of age."



Chrysanthemums, Dogwoods, Elms, Gladiolus, Hydran-gea, Juniper, Lliacs, Maple, Oak, Pines, and Roses. Do not use on Boston Ivy.
