**IF swallowed:** Induce vomiting. Atropine only by injection is an antidote.

**ENVIRONMENTAL HAZARDS**

This product is toxic to fish, birds and other wildlife. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean highwater mark. Do not contaminate water when disposing of equipment washwaters. Do not apply where runoff is likely to occur. Use this product only as specified on this label.

**DIRECTIONS FOR USE**

is a violation of Federal Law to use this product in a manner inconsistent with it's labeling. Not for use on turf being grown for sale or other commercial use such as sod, or for commercial seed production or research purposes.

**FOR THE FOLLOWING INSECTS**

Controls Chinch Bugs, Sod Webworms (Lawn Moths), Ants, Brown Dog Ticks, Crickets, Cutworms, Earwigs, Sowbugs (Pillbugs) and Hyperodes (Turfgrass) Weevils infesting lawns and other ornamental areas. Controls larvae of Japanese Beetle and European Chafer.

**SURFACE INSECTS**

Apply this product uniformly over the turf area at the rate of 1 pound per 1,000 sq.ft. Make the first treatment when insects first appear and retreat as needed. It is not necessary to water in for control of surface insects.

**SOIL INSECTS**

To control Hyperodes (Turfgrass) Weevils, apply at the rate of 2 pounds per 1,000 sq. ft. Treat suspected problem areas in mid-April and again in mid-May. Consult your local Agricultural Extension Service specialist for the best time to treat in your area. For best results in the control of soil insects, product should be watered in either by rainfall or irrigation.

**SOIL INSECTS (cont.)**

For control of larvae of Japanese Beetle and European Chafer, apply at the rate of 2 pounds per 1000 sq. ft. For best results, follow with adequate sprinkling to wash material into turf. Consult your local agricultural Extension Service for the best time to treat in your area.
