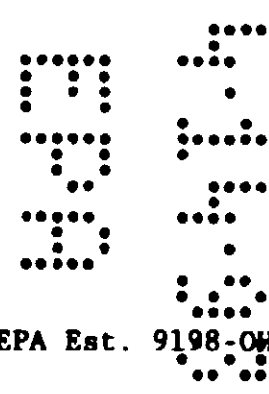

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

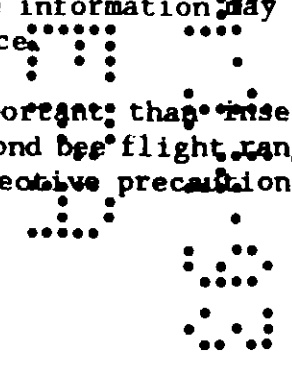

**ENVIRONMENTAL HAZARDS**
