PREMISE & BAND TREATMENT AROUND HOME FOUNDATIONS - Apply a band of Granules 5 feet wide around the dwelling next to the house foundation as a barrier against insects invading the home. Use 4 ounces of product to treat a band 5 feet wide and 20 feet long around the foundation. One pound will treat up to 500 Sq. Ft.(5'x 100' band).
