Dear Mr. Paradiso:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended, is acceptable provided that you make the labeling change indicated below before you release the product for shipment bearing the amended labeling:

Substitute the following Environmental Hazards section:

This product is toxic to birds, fish, and aquatic invertebrates. Birds feeding in treated areas may be killed. Clean up spilled product to reduce exposure to wildlife. Do not apply directly to water, to areas where surface water is present, or to intertidal areas below the mean high water mark. Runoff may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment washwaters.

We have noted the statement in your letter that the headings "FOR HOMEOWNER USE" and "FOR PROFESSIONAL/COMMERCIAL USE ONLY" will not appear above the Storage and Disposal directions on the final printed labeling.

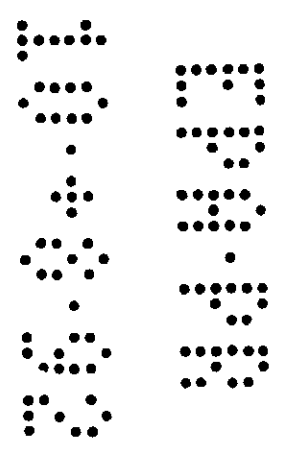

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION

May be harmful if swallowed. Do not take internally. Avoid contact with eyes, skin, and clothing. Wash thoroughly after handling. Wash contaminated clothing before reuse. Flush contaminated eyes with plenty of water and get medical attention if irritation develops or persists. Keep children and pets off treated areas until this material is washed into the soil and grass is dry.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. If possible vomiting should be induced under medical supervision. Have victim drink 1 or 2 glasses of water and induce vomiting by touching the back of the throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

IF INHALED: Remove victim to fresh air. Apply artificial respiration if indicated.

IF ON SKIN: Remove contaminated clothing and wash affected areas with soap and water.

IF IN EYES: Flush eyes with plenty of water. Call a physician immediately.

NOTE TO PHYSICIAN: Chlorpyrifos is a cholinesterase inhibitor. Treat symptomatically. Atropine only by injection is an antidote.

This product is toxic to fish, birds and other wildlife. Keep out of any body of water. Do not contaminate water by cleaning of equipment or disposal of wastes. Do not apply where runoff is likely to occur. Use this product only as specified on this label.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

TO CONTROL CHINCH BUGS, SOD WEBWORMS, ANTS, ARMYWORMS, BROWN DOG TICKS, CRICKETS, CUTWORMS, EARWIGS, FLEAS AND SOWBUGS.

Uniformly apply 5 lbs./1,000 sq. ft. or 25 lbs. to cover 5,000 sq. ft. of noncrop turf grass area using any hand or power-operated gravity or rotary type spreader designed for application of granular materials. Treat when insects first appear; re-treat as needed. To help obtain uniform distribution, apply one-half the required amount of product in one direction; then apply the balance at a right angle. Immediately after application, thoroughly water the treated turf to wash the insecticide into the zone of insect infestation.

SUGGESTED SPREADER SETTINGS

#5 on Model B Cyclone Spreader

Walking speed and spreader condition may require setting adjustment.

STORAGE AND DISPOSAL

FOR HOMEOWNER USE ONLY:

Do not contaminate water, food or feed by storage and disposal.
