WHERE TO USE

For use only on Bermudagrass lawns since Bermuda is resistant to herbicide action of Kerb. It also is not effective against Nutgrass, Johnsongrass, or any number of composite family plants such as Dandelion, Dogfennel, Groundsel, Sow Thistle and Wild Lettuce or leguminous species such as Clover or Black Medic. These must be controlled by other suitable EPA approved herbicides.

This product is especially effective for pre and post-emergence control of Poa annua (Annual Bluegrass) growing in Bermudagrass. It will control "Poa" from pre-germination and seedling stages through tillering, heading and seed formation. It kills plants slowly. Target weeds may first become dark green and then gradually turn yellow and die over a 3 to 5 week period.

The following plants are sensitive to Kerb treatments and should not be treated unless extensive damage can be tolerated: Dichondra, Bluegrass, Annual and Perennial Ryegrass (includes all new patented strains of Ryegrass), Fescue grasses and Bentgrass.
