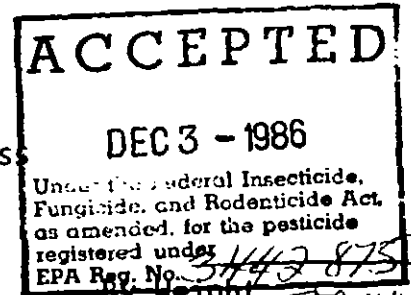

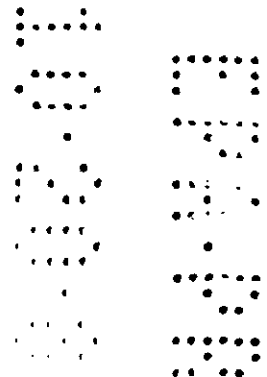

**DIRECTIONS FOR USE**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Read all Directions Carefully Before Applying

Vertagreen Sprayable Herbicide is a preemergence herbicide which is applied to established turfgrasses for the control of crabgrass, foxtails, goosegrass, annual bluegrass and other annual weed grasses. Vertagreen Sprayable Herbicide kills these weeds as they germinate. This product does not control emerged or established weeds.

Precautions: Vertagreen Sprayable Herbicide may thin established annual bluegrass (Poa annua) turfs. Vertagreen Sprayable Herbicide should not be applied in the spring to turfgrasses planted in previous fall unless the turf achieved full establishment and cover and was mowed at least 4 times during the fall. Vertagreen Sprayable Herbicide may thin winter grasses overseeded to dormant Bermudagrass areas if applied during the early spring.

Do not apply Vertagreen Sprayable Herbicide to golf course putting greens, Dichondra, newly sprigged areas of Bermudagrass, St. Augustinegrass or Centipedegrass.

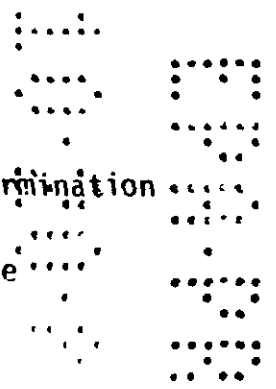
**APPLICATION DIRECTIONS**

Rates, Frequency and Timing of Application.

Apply Vertagreen Sprayable Herbicide one to two weeks prior to the germination of annual weed grasses.

Optimum weed control performance will be obtained if treated areas are irrigated soon after application.

Any cultural practices that disturb the soil such as aerification or verticutting, should be completed prior to application.

Cool Season Grasses

4.5-9.0 lbs/acre  
(1.6-3.2 ounces/1000 sq. ft.)

Warm Season Grasses

6-12 lbs/acre  
(2.2-4.4 ounces/1000 sq. ft.)

Within the listed rate ranges, use the lowest rate in areas with a short growing season or if only 6 to 8 weeks of control is desired. In areas with a long growing season or where season long control is desired, use rates at the upper end to the maximum rate in the range.

Do not reseed treated areas with desirable perennial grasses for a minimum of 42 days following treatment. Areas treated at the maximum rates should not be reseeded for a minimum of 90 days.

**APPLICATION EQUIPMENT AND DIRECTIONS**

Vertagreen Sprayable Herbicide should be mixed with water and applied as a spray. Apply in a minimum of 100 gallons of water per acre using any properly calibrated spray unit.

Vigorous, continuous agitation is required to keep Vertagreen Sprayable Herbicide in suspension. Sparger pipe agitation generally provides the best agitation.

When mixing Vertagreen Sprayable Herbicide with water, start by filling the spray tank 3/4 full of clean water. Start agitation and increase pump speed to operating pressure. Add the correct quantity of Vertagreen Sprayable Herbicide, continue agitation and finish filling the tank with water.

**Tank-Mixing Instructions**

Vertagreen Sprayable Herbicide is compatible with most commercially available turf grass pesticides and sprayable plant nutrients. Compatibility between specific products should be determined by mixing a small quantity of each additive in an appropriate quantity of water. Any changes in color, an abnormal precipitate, or rapid settling may indicate incompatibility.

When tank mixing several products always add to the spray tank in the following order:

Dry Flowables--Wettable/Dispersible Powders--Aqueous Suspensions--  
Flowables--Liquids--Solutions--Emulsifiable or Liquid Concentrates.

Always add materials to the spray tank while the agitation is operating and ensure that all products are completely dispersed in water.

Do not allow spray mixtures to stand overnight. If agitation must be stopped for any period of time, be certain that all material in the bottom of the tank is resuspended prior to resuming spray operations.

**STORAGE AND DISPOSAL**

Storage: Do not store in direct sunlight. Store in a cool dry place in original container only.
