1. With respect to the placement of the ingredient statement on the label, we will permit placement on the back panel only for container sizes up to 2 lbs. For container sizes smaller than 2 lbs, the ingredient statement must also appear on the front panel (or only on the front panel).

Flower beds: 2 capfuls per 12 sq ft (3' x4' bed area)	<ol style="list-style-type: none"> 1. Apply granules to soil around base of plant, sprinkling evenly in the area under the branches. 2. Work granules into top 1 to 2 inches of soil. 3. Water thoroughly after applying. For flower beds, sprinkle granules evenly over the bed.

Children and pets may re-enter after the treated area has been watered and allowed to dry.

HOW IT WORKS
 This product is absorbed by roots and moves through the entire plant. Even new growth is fed and Protected against insects for up to 6 weeks. Rain or watering cannot wash off this internal protection.
