The presence of snails and lougs can be detected by their shiny mucous-like trail. They are night feeders and prefer damp, cool places in the omamental garden, flowers, under boards or flowerpots and around fences, hedges and bushes.

DIRECTIONS FOR USE

<u>I Pound Treats up to 2,000 sc.ft.</u> It is a violation of Federal law to use this product in a manner in consistent with its labeling. Not for use on manner in consistent with its labeling. Not for use on turf being grown for sale or other commercial use as sod, or for commercial seed production or for research purposes. Water area to be treated thoroughly. Broad-cast Pursell Snail and Slug Killer Pellets late in the day in the areas likely to be infested. Apply to the soil and not directly on plants. Do not apply to edible parts or foliage. Scatter, do not leave in piles. In gardens and lawn areas insure pellets are applied around base of bedding plants and other low growing plants where snails and slugs hide. To avoid early damage to your garden, apply before snails and slugs annear at spino planting. apply before snails and slugs appear at spring planting.

Continuous watering and high temperatures cause this bait to gradually lose some of its effectiveness. Repeat applications every week to ten days during the spring and summer months. Treatment every two weeks dur-ing fall and winter months is usually satisfactory. Repeated treatments provide control of new broods emerging during this period. Three applications ten days apart usually gives control of new hatch. Apply 1 pound of this product to 2,000 sq.ft. of area.
