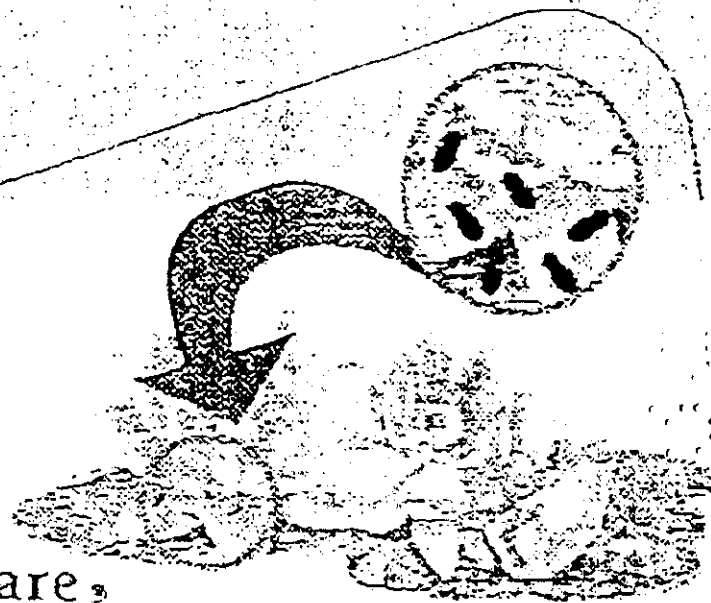

Aphids coming from nearby gardens and weeds can reinfest aquatic plants. Reapply **HERBAL APHID CONTROL** when aphids reappear. **HERBAL APHID CONTROL** can be applied as often as necessary. ~~For Use in Ornamental Ponds Only~~

DIRECTIONS FOR USE: It is a violation of federal law to use this product in a manner inconsistent with its labeling. Shake well before using. When aphids first appear spray all exposed plant parts with **HERBAL APHID CONTROL**. All plant parts must be thoroughly sprayed. **IMPORTANT:** Wait 5 minutes for aphids to die, then rinse off the plants with pond water or a fine mist from a garden hose. Aquatic plants must be rinsed off to remove dead insects and wash off the excess **HERBAL APHID CONTROL**. If allowed to dry, **HERBAL APHID CONTROL** can cause leaf curling on foliage plants like taro (*Colocasia esculenta*).

CAUTION: Do not use **HERBAL APHID CONTROL** on water lettuce (*Pistia stratiotes*). Do NOT use **HERBAL APHID CONTROL** when bees are in the area. Repeat application if insects reappear.

STORAGE AND DISPOSAL

Do not contaminate water or feed. Do not reuse container. Wrap container and put in trash.
