## APPLICATIONS

PRECISION CL-211 is used to inhibit the growth of algae, bacteria, and fungi in recirculating commercial and industrial cooling water systems. Before treatment with PRECISION CL-211, systems must be cleaned to remove algal growth, microbiological slime, and other deposits. Then the system should be treated with an initial slug addition of 6.9 to 13.9 fluid ounces of PRECISION CL-211 per 1,000 gallons of water in the system. Repeat the initial dosage until control is evident. Subsequent slug additions of 2.3 to 13.9 fluid ounces of PRECISION CL-211 per 1,000 gallons of water should be made every 1 to 5 days or as needed. The required frequency of treatment depends on the relative amount of bleedoff and the severity of the microbiological problem. Slug additions of PRECISION CL-211 should be made to the sump of water cooling towers.

## WARNING KEEP OUT OF THE REACH OF CHILDREN
