INSECTAPE is today's answer to more effective pest control. It works on simple contact. These easy-to-apply, 1" x 4" multi-layered strips kill roaches and waterbugs that walk across its surface. Only one application of INSECTAPE is needed to work around-the-clock to bring continuous relief. Length of effectiveness may vary in different situations.

The patented HERCON controlled release technology provides this long term control action. Whenever the non-fumigant insecticide on the surface is removed or disturbed by insect activity or by mopping and wiping, it is replenished continually from a specially designed storage layer sealed in the strip. Depending upon the degree of infestation, it will take from a few days to a few weeks before roach control is achieved.

Use INSECTAPE alone or as a supplemental residual treatment with roach sprays, dusts or baits. Good sanitation practices should be followed in either case.

INSECTAPE may also be used as the toxicant inside gypsy moth traps.

PRECAUTIONARY STATEMENTS

Do not open protective pouch until ready to use. Harmful if chewed or swallowed. Avoid contact with eyes and clothing. Do not contaminate food, food containers or cooking utensils. Wash hands with soap and water after handling. NOTE TO PHYSICIAN: Atropine is antidotal

INSECTAPE should be applied in dark and warm out-of-sight locations wherever roaches crawl or nest such as: inside cabinets, around pipes and under appliances. • Wipe or clean surfaces before applying. • To adhere, remove backing paper from strip. • Do not place strips in exposed locations where direct contact with children, pets, food or clothing is likely to occur. • Replace strips when effectiveness is diminished.

DO NOT USE IN FOOD AREAS OF FOOD PROCESSING PLANTS, RESTAURANTS OR OTHER AREAS WHERE FOOD IS COMMERCIALLY PREPARED OR PRO-CESSED. 


