The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, is acceptable provided that you make the labeling changes indicated below, prior to release for shipment of product bearing the amended labeling.

1. Revise the "Precautionary Statements" to read:

"Caution: Avoid contact with eyes and mouth. Do not open protective pouch until ready to use. After prolonged storage, a small amount of liquid may form on the strip. Do not get liquid in mouth or in eyes. Wash hands thoroughly with soap and water after handling strip."

2. Revise the second sentence under the "Environmental Hazards" section to read, "Do not apply directly to water."

3. We have no objection to any of the proposed new uses; however, the wording "including but not limited to" implies other unnamed uses and, therefore, goes beyond the sites and pests on the proposed label. This term must be deleted. The statement


