To install or replace strip in mosquito trap: [See optional graphics] Open canister/tube and take out packet containing pesticide strip, red velour landing strip, and black zip nylon cable tie. Open the enclosed packet and take out pesticide strip. Staple pesticide strip to the inside top rim of the canister/tube. (Step 1 /1.) Place red velour landing strip inside the tube so the strip reaches from the bottom of the canister/tube up and over the rim of the canister/tube. (Step 2./2.) Bend the red velour strip over the top edge. Thread zip tie though one side hole and up through the hole in the top of the lid. (Step 3./3.) Screw lid on to the canister making sure to secure red velour strip in place. (Step 4./4.) Slide zip tie around lid and tighten to itself to secure lid. (Step 5/5.) Fill canister/tube with water up to the side hole level. Place canister (tube) on ground or up to 3 feet above the ground in an area away from children and pets. Replace pesticide strip after 45 days.


