- Set the omni directional trap by sliding the vanes together so slots interlock (Fig. 1).
- ATTACHING THE BAIT PACK [for products with combo sex/floral lure bait pack]: Simply peel away the plastic layer, which covers the "windows" of the sex lure and floral lure compartments (Fig. 4). Next, peel of the backing paper covering the sticky side of the pouch (Fig. 5); press this sticky side against one side of the vane (Fig. 6). For traps with smaller vanes, fold the bait pack and press the sticky side against both sides of the vane (Fig. 7). DO NOT REMOVE LURES FROM BAIT PACK.

ATTACHING THE SEX LURE [for products without the combo sex/floral lure bait pack]: Remove the lure from its protective pouch. Peel off the backing paper covering the sticky side of sex lure. Attach sex lure by pressing the sticky side against the yellow vane surface (Fig. 2).

ATTACHING THE FLORAL LURE LURE [for products without the combo sex/floral lure bait pack]: Remove the lure from its protective pouch. Thread lure through the slots of the two vanes, gently pushing down to lock floral lure dispenser in place (Fig. 3).

- 4. HANGING THE TRAP: Insert about 3 to 4 inches of the hang tie through the holes in the top part of the vane assembly. Tightly twist the tie to secure the trap in place. Hang the trap by attaching the long end of the hang tie to a post or stake or optional trap stand. The bottom of the bag should be at least 1 foot about the ground (Fig. 8) and the trap free to move in the wind without hitting any obstruction. Hang the trap where small children cannot reach it.
- 5. USING THE TRAP: to intercept beetles heading toward the trap, place the stake with the trap about 30 feet downwind from foliage. Do not place the trap near or in the foliage as it will attract more beetles to it. For maximum effectiveness, use one trap per 1/8 acre. Most Japanese beetles are active and flying during sunny days with temperatures between 70°F -95°F and from mid-morning through mid-afternoon. Check the bag periodically. Replace it when the lower portion is filled with beetles, or every five days to reduce the possibility of other beetles being repelled by the odor of the dead beetles.
- 6. BEETLES (BAG) DISPOSAL: Knot the top funnel portion of filled bag before disposing it in trash receptacle. Generally, beetles trapped in the bag will die after several hours in the heat and sun. To make sure that beetles are dead, leave sealed bags in the sun to kill trapped insects before disposal.
- 7. LURE DISPOSAL: Wrap used lures and put in trash receptacle for collection.
