Use on tree stands containing lodgepole pine (*Pinus contorta*), ponderosa pine (P. ponderosa), whitebark pine (P. albicaulis), loblolly pine and other pines that are hosts to certain bark beetles such as mountain pine beetle (*Dendroctonus ponderosae*), red turpentine beetle (*D. valens*), Western Pine beetle (*Dendroctonus brevicomis*), and three ambrosia beetle species (*Xylosandrus compactus, X. crassiusculus and X. saxesen*).

**Tree Stands**: Apply 150 to 500 gm of active ingredient (1 kg to 3.33 kg of product) per acre with one application per season. Use in areas such as forest; suburban, municipal and shade tree area, recreational area such as campgrounds, golf courses, parks and parkways; ornamental, shade tree forest plantings; shelter belts and rights of way and other easements. To ensure proper rate and method of application, make application by or under the supervision of a qualified person.

**Individual Trees**: Using a Hercon approved modified hydroseeder or blower, spray individual trees to a height of 7 meters with a mixture that includes an inert sticker such as MICRO-TAC®, DISRUPT MICRO-FLAKE® VBN, a thickener such as MICRO-THIC and water to hold flakes on the tree trunk and other plant parts. Spray 7 meters up into the tree and on the trunk of the tree to protect individual trees. When treating small forested areas or campgrounds use the modified blower to broadcast flakes without sticker.

**Aerial Equipment:** Place the DISRUPT Micro-Flake VBN in the appropriate hoppers mounted on the plane or helicopter. Spray DISRUPT Micro-Flake VBN into the tree canopy allowing the product to fall down and through the top of the trees. DISRUPT Micro-Flake VBN can be applied with or without the sticker depending on the area and stand classification.
