LABEL LAYOUT

This label is designed for application to unprinted metal drums. It will be printed in green ink on yellow label paper measuring $7\frac{1}{2}$ inches high by $17\frac{1}{2}$ inches wide. The label is distributed into three equal panels designated 1, 2, and 3 from left to right.

Panel 1 is entirely filled with an FMC logo measuring $4\frac{7}{8}$ inches wide by $6\frac{1}{2}$ inches high.

Panel 2, with the heading "Directions for use", contains the instructions, ingredient statement, USDA Reg. No., and net contents statements.

Panel 3, with the heading "CAUTION", contains the caution statement and disclaimers.

The product name is centered above panels 2 and 3 in letters about $1\frac{3}{4}$ inches high. The address is centered below these two panels. The printing type styles and sizes are indicated adjacent to the items of the proposed text.
