<u>CITRUS FRUITS (Postharvest): Blue mold, green mold, and stem-end rot.</u> Use 10 gallons Freshgard 500 plus 90 gallons of water (5000 ppm actual). Dip 1 minute, flood, or spray previously washed fruit in suspension. Do not rinse.

Mix 6 gallons Freshgard 500 with 94 gallons of Sta-Fresh 215 wax emulsion (3000 ppm actual). Apply by spray-brush applicator to washed and partially dried fruit at the rate of 1 gallon per 10,000 lbs. of fruit. Wash applicator brushes and spray nozzles with water immediately following each use.
