## Directions for Use

**Citrus Fruits** (Postharvest): Blue mold, green mold, and stem-end rot. Mix 1 volume of Fungicide Conc. 2020 with 100 volumes Flavorseal wax coating for 1000 ppm active ingredient. Mix 1 volume Fungicide Conc. 2020 with 33 volumes Flavorseal wax for 3000 ppm when treating sensitive fruit and to control the sporulation of blue and green molds. Apply 1 gallon of Flavorseal wax plus Fungicide to each 5000 lbs. of cleaned citrus fruit. The final Flavorseal wax plus Fungicide formulation is to be prepared only by an FMC serviceman and applied only in an FMC Flavorseal wax spray applicator.

**Environmental precaution.** This product is toxic to fish. Keep out of lakes, streams, or ponds. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on this label.
