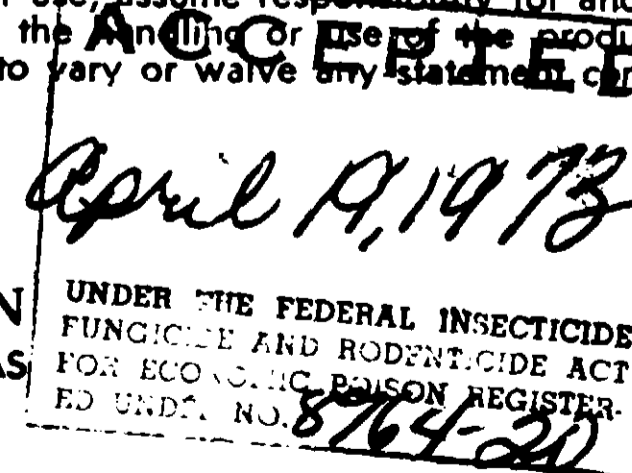
CITRUS FRUITS (Postharvest): Blue mold, green mold, and stem-end rot. Apply Sta-Fresh 419 high gloss, fungicidal fruit coating to washed and partially dried fruit with spray-brush applicator at the rate of one gallon per 10,000 lbs. of fruit. Rinse applicator brushes and nozzles with water immediately following each use.
