## **Directions For Use**

Citrus Fruits (Postharvest): Green mold, blue mold, stem-end rot

DRENCH OR DIP TREATMENT. Use 1 volume Freshgard 605 plus 29 volumes water for 1.0% active ingredient. Adjust if necessary to pH 8 0-9.0 with hydrochloric acid. Apply immediately after harvest by drench or dip until fruit is thoroughly wet. Allow to remain on fruit at least one minute before rinsing and washing. If fruit is degreened or stored wet, adjust storage conditions to obtain fruit drying with n 24 to 48 hours to avoid water spot injury. Treat one time only

When fruit remains wet in excess of 48 hours after drench or direction, reduce treating concentration to 0.5% active ingredient. Use 1 volume Freshgard 605 to 59 volumes water for 0.5% active ingredient. Adjust to pH 8.0-9.0 if necessary with hydrochloric acid. Treat one time only.

SPRAY TREATMENT. Add 1 volume Freshgard 605 to 14 volumes water for 2.0% active ingredient. Adjust solution pH 8 0-9.0 if necessary with hydrochloric acid. Spray on cleaned fruit followed by drying. Effectiveness is reduced by rinsing. Treat one time only
