This is in response to your amendment of revised labeling reflecting change in wording of "Directions for Use" and correction of error in "Use Dilution Table."

The labeling referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended is acceptable subject to the following comment.

Revise the "Environmental Hazards" statement to read:

"This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting utority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the sewaage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.
