DIRECTIONS

Aqua Kleer should be injected into turbulent water at the rate of 10 gallons product/ cu. ft./ second for 30 - 40 minutes. Water in the ditch may be reduced, but there should be sufficient water to cover weeds. Any power sprayer with sufficient volume to deliver the amount of solvent in the period of time specified and maintain 40 to 50 pounds pressure is suitable to apply Aqua Kleer.

EXAMPLE: The ditch is carrying 7 second feet of water, adjust spray gun and pressure to deliver 1 gallon per minute, put 30 gallons of Aqua Kleer in sprayer and put spray gun in turbulent water, run sprayer until the 30 gallons has been used.

Treated water may be used for furrow or flood irrigation as soon as it clears.

TIME OF APPLICATION: Apply before weed growth becomes matted at the surface or causes channeling of the water flow.

Aqua Kleer when properly mixed with the water in a ditch will kill most submerged water weeds, for 2 miles of ditch. If control for more than two miles is desired retreat downstream at 1/2 dose as needed and complete each addition before the approaching blanket (from initial application) reaches the retreatment site.

WEEDS CONTROLLED: American pond weed, Sago pondweed, waterweed and other submerged aquatic weeds - frequently called mosses or pondweeds.
