





#### **SPOT TREATMENT**

Ants: Apply 1½ teaspoons over and around each individual ant hill.

Digger Wasps: Apply 1½ teaspoons in and around each ground nest opening. Make application about dusk when the wasps are not active.

#### BAND TREATMENT AROUND FOUNDATION

The following insects are commonly found around or ever the foundation of houses as well as in the lawn. Certain of these insects any even. enter the house.

Ants, Brown dog ticks, Clover mites, Crickets. Earwigs, Fleas, Millipedes, Sowbugs, Springtails (Collembola).
