
IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

E-Z CLOR* TRICHLOR 70 LARGE TABS help prevent growth of algae, bacteria and fungi in swimming pools. Place tablet in plastic skimmer basket. Avoid metal objects.

- 1. Before using E-Z Clor Trichlor 70 Large Tabs for the first time, pool water should be stabilized with E-Z Clor Save chlorine stabilizer. Follow directions on the label for that product. Stabilizer increases the effective life of chlorine by reducing loss caused by the sun's rays.
- 2. Then treat the pool with a shock dose of chlorinating compound using a quickly soluble form such as E-Z Clor Quick Dissolve Concentrated Pool Chlorinating Compound. Follow directions on the label for that product. After several hours, check the chlorine residual to determine if at least 1.0 to 2.0 ppm has been obtained. If the chlorine residual is less than 1.0 to 2.0 ppm, repeat the shock dose until at least that level has been obtained.
- 3. Place one E-Z Clor Trichlor 70 Large Tab tablet in the pool's skimmer to provide daily chlorination. Add additional tablets if needed to maintain a chlorine residual of 1.0 to 2.0 ppm as determined by a suitable test kit. Give a shock dose (see No. 2 above) whenever algae first becomes visible.

Keep pH of water between 7.2 - 7.6. Use an E-Z Clor test kit for accurate chlorine and pH control.
