GENERAL INFORMATION

HABCO 10B is a pelletized product for dry application to the soil for control of certain undesirable woody plants in non-cultivated areas such as utility, highway, pipeline and railroad rights of way, and other industrial sites such as fence rows. HABCO 10B is suitable for application in measured amounts for spot treatment. Effects are slow to appear and will not become apparent until the chemical has been carried into the root zone of the plants by moisture.

DESCRIPTION OF PRODUCT

HABCO 10B is a non-corrosive to iron products, non-volatile, non-flammable pelletized product.

RECOMMENDATIONS FOR USE

Apply HABCO 10B as a basal treatment. Applications can be made at anytime except when ground is frozen. It is not recommended for use in marshy areas or in standing water.

For control of woody species such as willow, cottonwood, alder, poplar and certain other undesirable woody plants:

BASAL—Spread 1 to 2 tablespoonfuls (1/2 to 1 ounce) on the ground (to cover an area 1/2 to 1 sq. ft.) at the base of each brush cluster; apply to uphill side if ground is not level. On large clumps of brush or on large trees, apply 1/2 tablespoonful to each of 3 or 4 spots around the base of the brush or tree.
