PRECAUTIONARY STATEMENTS

Hazarda to Humans and Domestic Animals CAUTION: Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. If swallowed: Call a physician or Pcison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. Never induce vomiting or give anything by mouth to an unconscious person. If on skin: Wash contaminated clothing and wash affected areas with plenty of soap and water. If In eyes: Flush eyes with plenty of water. Call a physician if irritation persists, If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated. NOTE TO PHYSICIAN: Active ingredient is a cholinesterase inhibitor. Treat symptomatically, Atropine is antidotal.
