Sprayer Instructions:

How to prime and care for your sprayer:

- After shaking product well, remove cap from container and replace with sprayer hose and cap assembly. Tighten securely.
- 2 Turn sprayer nozzle one half turn counter-clockwise. Hold sprayer below the level of container and prime by pumping trigger 10-15 times until product is dispensed. Adjust nozzle to fine spray or jot stream as needed.
- To store, turn nozzle to "OFF" position and store with sprayer above level of liquid in container to prevent leakage

NOTE: Do not reuse container.

# INDOORS

Roaches, Ants, Crickets, Silverfish, Spiders, Centipedes, Earwigs, Waterbugs, Pelmetto bugs, Carpet Beetles, Dry-wood Termites (polilla): Spray heavily into cracks, crevices and openings around pipes. Spray until wet behind and beneath cabinets and apptances, under rugs, around carpet edges, basoboards, doors and window frames and other points of entry, storage areas and any localized area infested with these pests. For best results use at least monthly imore often if reinfestations occur NOTE: Dry-wood termites will be killed only if they come in contact with this product. Use of this product to control dry-wood termites should not be considered a substitute for treatment by a professional pest control operator.

Fleas & Brown Dog Ticks: Thoroughly spray intested area around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Spot test for color fastness. Applications should be repeated as infestations warrant and as reinfestations occur. Old bedding of pets should be removed and replaced with clean, fresh bedding after treatment of pet area. Also treat pets with a EPA approved product registered for pet use. Do not treat pets with it is product.

### **OUTDOORS**

Flies, Mosquitoes, Moths, Wasps and Hornets, Ants, Crickets, Earwigs,

Centipedes, Tree Termites (comejénes) and other insects outdoors: Spray outside surfaces of screens, doors and window frames or wherever insects may enter. Also treat surfaces around light fixtures on porches, in garages and other places where insects are seen. For treatment of localized intestations where there are weeds or brushy non-crop areas, spr.; thoroughly. Repeat every two weeks or as often as needed. For tree termites, treat specific areas where termite traits and nests are seen. Make holes in the nest and apply enough product to saturate the nest. Thoroughly wet tree trunks, surface roots and termite traits going into the nest. Also treat bushes and surrounding areas. Repeat every two weeks or as necessary.

### STORAGE AND DISPOSAL

Store in a cool place away from heat, direct sunlight, or open flame. Do not reuse container. Discard container in trash.
