# **PRECAUTIONARY STATEMENTS**

#### Hazards to Humans and Domestic Animals

If In eyes: Flush eyes with plenty of water. Call a physician if irritation persists. If Inhaled: Remove victim to fresh air. Apply artificial respiration if indicated. NOTE TO PHYSICIAN: This product may cause cholinesterase inhibition. Atropine is antidotal. 2-PAM may be effective as an adjunct to atropine.
