DIRECTIONS FOR USE:

It is a violation of Federal law to use this product in a manner inconsistent with it's labeling.

Hold nozzle about one foot away from animal while spraying. Treat around ears, head and neck first, thoroughly saturating hair, being careful not to spray in eyes or mouth of animal. Next, beginning at the tail, spray against the natural lay of the hair, fluffing and parting hair with your hand so that spray will contact skin. Continue over entire coat until thoroughly wet. Special attention should be given to the back of the head and neck and along the top of animal's back. Treatment may be repeated after 24 hours. To reduce reinfestation, thoroughly spray the animal's bedding and other resting places until the surface is slightly moist. Where there is a dog house in use, treat inside thoroughly spraying floor, cracks and crevices until wet. Old bedding material should be removed and replaced with clean, fresh bedding. Repeat as necessary.

NOTE: A complete flea & tick control program includes three steps: (1) pet treatment, (2) treatment of home and (3) grounds. To prevent reinfestation and for long-lasting control of adult fleas AND larvae on premises and in outdoor areas, use Rid-a-Bug Flea & Tick Killer with Dursban*.
