CAUTION

Hazards to Humans and Domestic Animals

Harmful if swallowed or absorbed through skin. Avoid breathing vapor and spray mist. Avoid contact with skin and eyes. Remove pets, birds and cover fish aquariums before spraying. Do not apply directly to or around food. Cover or remove any food utensils and food processing equipment during application. Do not apply while food processing is underway. Statement of Practical Treatment

If Swallowed: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Repeat until vomit fluid is clear. **Never induce vomiting or give anything by mouth to an unconscious person.** **If on Skin:** Wash contaminated clothing and wash affected areas with plenty of soap and water. **If In Eyes:** Flush eyes with plenty of water. Call a physician if irritation persists. **If Inhaled:** Remove victim to fresh air. Apply artificial respiration if indicated.

Used as directed, Hot Shot Flea & Tick Spray quickly relieves pets of bothersome flea and tick problems.

Hot Shot Flea & Tick Spray will kill Fleas on Cats and Brown Dog Ticks and Fleas on Dogs.

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure that the animal's entire body is covered, including the legs and under the body. As you spray, fluff the hair so the spray will penetrate to the skin. Make sure spray wets ticks thoroughly. Do not spray into the eyes, face or on scrotum. Repeat as needed.

For cats apply at a rate of one second per pound of body weight. (For example: 5 seconds of total spraying on a 5 pound animal). For dogs apply at the rate of two seconds per pound of body weight for thin or short haired dogs and up to eight seconds per pound of body weight for heavy or long haired dogs.
