Dear Ms. Tryson:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Reinstate "*cis-trans isomer ratio: Min 35% (+/-) cis, Max. 65% (+/-) trans" to the Ingredients Statement.
- 2. Following the paragraph that identifies where the product can be used add: "Non-food/feed areas include area such as (but not limited to) garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage areas (after canning or bottling).



Residually Kills: Roaches, Ants, Spiders, Crickets, Silverfish, Earwigs and other listed insects.

For use in homes and non-food areas of kennels, commercial buildings, warehouses, theaters, office buildings, schools, hotels, motels, restaurants and food processing facilities.

STOP. READ ENTIRE LABEL BEFORE USE.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Use this residual spray as a spot or crack and crevice treatment to control cockroaches, waterbugs, silverfish, ticks, fleas and other insects listed below. Apply this product to localized areas where pests are found or may occur. Spray surfaces until wet. Care should be taken to avoid depositing the product onto exposed surfaces or introducing the material into the air. Avoid contamination of food or food processing surfaces. Do not use in commercial food processing. preparation, food storage or serving areas. In the home, all food processing surfaces and utensils should be covered during treatment, or thoroughly washed before use. Exposed food should be covered or removed. Remove pets, birds and cover fish aquariums before spraying. Do not allow children or pets to contact treated surfaces until spray has dried.

FOR SPOT TREATMENT

To kill Ants, Cockroaches, Crickets, Silverfish, Spiders, Sowbugs, Earwigs and Carpet Beetles: Spray areas where these pests are found or may hide, including dark corners of rooms and closets; cracks and crevices in walls; along baseboards and door and window frames; behind and beneath sinks, stoves, refrigerators and cabinets; and around garbage cans, plumbing and other utility installations. Pests driven out of hiding places should be sprayed directly. For ants, apply to ant trails, also around doors and windows and wherever else these pests may find entrance.

Files and Mosquitoes: Use only out-of-doors as an aid in reducing annoyance from these insects. Spray outside surfaces of window and door frames as well as other areas where these pests may enter the home. Also spray dark corners and localized resting areas (such as under eaves) or porches, patios and garages where these insects may congregate. Files and mosquitoes coming to rest on treated surfaces will be killed.

To kill Brown Dog Ticks and Fless: Thoroughly apply as a spot treatment to infested areas such as pet beds and resting quarters; nearby cracks and crevices; along and behind baseboards; window and door frames and localized areas of floor and floor coverings where these pests may be present. Old bedding should be removed and replaced with clean, fresh bedding after treatment. DO NOT SPRAY PETS WITH THIS PRODUCT. Pets should be treated with a registered product for flea and tick control in conjunction with this treatment.

FOR CRACKS AND CREVICES

To kill Ants, Cockroaches, Crickets, Silverfish, Sowbugs, Spiders, Brown Dog Ticks, Fleas, Earwigs and Carpet Beetles: Apply spray in small amounts directly into cracks and crevices.

STORAGE AND DISPOSAL

Store in a cool dry area away from heat and open flame. **Disposal:** Do Not Puncture or Incinerate! **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.

PRECAUTIONARY STATEMENTS Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed, inhaled or absorbed through skin. Avoid breathing spray mist. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.

First Aid

If Swallowed: Call Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the Poison Control Center or doctor. Do not give anything by mouth to an unconscious person. If Inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a Poison Control Center or doctor for further treatment advice. If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice.

Have the product container or label with you when calling a Poison Control Center or doctoror going for treatment.
