PRECAUTIONS: Do not use as a space spray — this product is designed for spot application only. Do not spray food, humans or pets. Do not use in commercial food preparation areas or in edible products areas of food processing plants. Harmful if swallowed. Do not allow children in treated areas until surfaces are dry. Wash after handling and before eating or smoking. Avoid prolonged and repeated contact with skin. In case of contact, wash with soap and water. Avoid inhalation. To avoid possible staining test first in any inconspicuous place and check results the following day.

ENVIRONMENTAL

This product is toxic to fish and other wildlife. Keep out of lakes, streams or ponds. Apply product only as specified on this label.

PHYSICAL & CHEMICAL

Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F. may cause bursting. **DO NOT USE NEAR FIRE OR OPEN FLAME.**

STATEMENT OF TOXICITY: THE TREATMENT

If swallowed — Call a physician or Poison Control Center immediately. Gastric lavage is indicated if material was taken internally. **DO NOT INDUCE VOMITING.** Vomiting may cause aspiration pneumonia. If inhaled — Remove victim to fresh air. Apply artificial respiration if indicated. If on skin — Remove contaminated clothing and wash affected areas with soap and water. If in eyes — Flush eyes with plenty of water. Get medical attention if irritation persists. **NOTE TO PHYSICIAN:** Diazinon is a cholinesterase inhibitor. If symptoms of cholinesterase inhibition are present, atropine sulfate is antidotal. 2-PAM is also antidotal and may be administered in conjunction with atropine.

DIRECTIONS:

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For spot application only. Do not use as a space spray.

Remove protective cap. Hold dispenser upright, point valve opening away from face, and about 8-10 inches from surface being treated. Aim nozzle, press plastic button to release spray. Apply spray covering 1 ft. x 2 ft. area per second to infested cracks, crevices, baseboards and areas where the insects rest and hide. Moisten surface thoroughly, avoid running or streaking. Spray leaves an invisible film, kills the many insects crawling over it.

TO KILL ROACHES, WASPS, BEES, AND CERTAIN OTHER CRAWLING INSECTS — spray infested areas around refrigerators, under sinks, behind shelving, book cases and other hiding places; particularly infested cracks, crevices and baseboards. Repeat as necessary.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **STORAGE:** Store in a cool dry area away from heat or open flame. **DISPOSAL:** Replace cap and discard containers in trash. Do not incinerate or puncture.
