DIRECTIONS FOR USE

To kill roaches, ants, waterbugs, silverfish, spiders, crickets: Spray heavily into all cracks, around baseboards and other places where these insects hide. Also spray until wet, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, etc. Spray other localized areas infested with these pests. Repeat treatment as required.

To kill carpet beetles: Make localized application to areas of the floor andbaseboards. Spray directly into cracks and under carpets where insects may be found. Treat crevices, cracks or closets and infested areas of shelvings. Repeat as necessary.

To kill Brown Dog ticks: Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, sleeping quarters of household pets and localized areas of floors and floor coverings. Application should be repeated as infestations warrant, and as re-infestations occur. Fresh bedding should be placed in animal quarters following treatment. Do not treat animals with this formulation.

To kill flies, mosquitoes, wasps and flying moths outdoors: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, windows or wherever these insects may enter the room. A'so treat surfaces around light fixtures on porches, in garages and other places where these insects alight or congregate.

To kill fleas, chiggers, ants and Brown Dog ticks outdoors: For treatment of localized infestations of these insects in outdoor areas where there is no vegetation, spray infested areas thoroughly. For ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and re-infestations occur.

Caution: Do not use as a space spray. This product is designed for spot application only. Do not spray food, humans or pets. Repeated or prolonged contact with skin can cause toxic symptoms. In case of contact wash with soap and water. Avoid inhalation. Harmful if swallowed. Wash after handling. Do not contaminate or store near feed or foodstuffs. To avoid possible staining, test first in an inconspicuous place and check results the next day.
