Dear Mr. Piranian:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below.

Under the "PHYSICAL AND CHEMICAL HAZARDS" section, change "COMBUSTIBLE" to read "FLAMMABLE."

Under the "STATEMENT OF PRACTICAL TREATMENT" add the following sentences to the sentence following "IF SWALLOWED:" "This product contains petroleum distillate. Do not induce vomiting. Vomiting may cause aspiration pneumonia."

Add the following sentence to the sentence following "IF ON SKIN:" "Get medical attention if irritation persists."

Change the sentence following "IF IN EYES" to read "Flush eyes with plenty of water. Get medical attention if irritation persists."

On the Right Back Panel, change the statement "KEEP CAN UPRIGHT WHEN SPRAYING" to read "KEEP CAN UPRIGHT WHEN SPOT TREATING."

FOR SPOT APPLICATION ONLY. DO NOT USE AS A SPACE SPRAY.

Remove protective cap. Hold dispenser upright, point valve opening away from face, and about 8-10 inches from surface being treated. Aim nozzle, press plastic button to release spray. Spray until moist, do not soak. Repeat as necessary. Windows and doors may be left open while spraying.

BEDBUGS: Spray upholstered furniture in tufts, and especially under and around seams and ends of fabric. Take bed apart. Spray mattress seams, bedsprings, bed frame, and joints. Spray floor, rugs, floor boards, moldings, baseboards and furniture legs. Air premises thoroughly and permit treatment to dry before using.

FLEAS: Spray floors, floor coverings, and other places infested by fleas. Spray sleeping quarters of animal pets, and change bedding after spraying. Do not use on animal or pets.
