On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. - 2. Make the following label changes:
  - A. Revise the EPA Registration Number to read, "EPA Reg. No. 8848-65."
  - B. Revise the statement to read, "NOT FOR USE IN FEDERALLY INSPECTED MEAT AND POULTRY PLANTS."
  - C. The term active ingredient should be plural.

- D. Revise the "IMPORTANT" section of your labeling to read as that on the Black Jack Automatic Indoor Fogger Roach Bomber II (EPA Reg. No. 8848-68).
- 3. On the Confidential Statement of Formula (CSF) statement the flash point (block 9) is listed as "<70 °F." This is too broad. If the flash point for your product is less than 20 °F then you must add "Extremely flammable" to the beginning of the Physical of Chemical Hazards section. At the very least you must add "Flammable" to the beginning of the section. Please provide the Agency with an accurate flash point and reflect it on the CSF. See 40 CFR 156.10 for more information.

The pH of the product should be reflected in block 8 on the CSF.

- 4. Please note that EPA recently published in the Federal Register a rule for total release fogger pesticides. When this rule becomes effective you may be required to revise your labeling.
- 5. Submit two copies of the revised final printed label for the record. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

## Hazards To Humans & Domestic Animals

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

One 6 ounce aerosol can treats up to 6,000 cubic feet of unobstructed area (a room 30' x 25' with an 8 foot ceiling).

For Fleas and Ticks, use one 6 ounce can for every 1,500 cubic feet of room space.

## STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area inaccessible to children and pets and away from heat, sparks, open flame or pilot light. DISPOSALI Replace cap, wrap container in several layers of newspaper and discard in trasii. Do not incinerate or puncture.

### HOW TO USE:

### Step 1: PREPARATION

Open cupboards, cabinets, trunks, and doors to area to be treated to allow maximum kill in all areas where insects can hide and breed. Close outside doors and windows and shut off fans and air conditioning to maximize killing power of fog. Remove pets, birds, and tightly cover or remove fish bowls and aquariums before spraying. Cover waxed wood floors and waxed furniture in the immediate area surrounding the fogger (Newspapers may be used). Remove or cover exposed foods, dishes, utensils or food handling equipment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Shut off electrical appliances, Do not place activated forger in a cabinet or under a counter or table.

## Step 2: ACTIVATION OF FOGGER

SHAKE WELL JUST BEFORE USING. Place a section of newspaper on a level floor surface in center of room to be treated. NOTE: Do NOT place fogger on water-stainable surface. Do not place can within 6 feet of pilot lights. Tilt can opening away from face and depress tab firmly with thumb until it clicks in locked position. Aiming spray away from face, set fogger on newspaper, leave room and close door. After activation, leave room or house at once. Keep area closed for 2 hours (30 minutes for flying insects) before airing out... Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.
