The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the tetramethrin, permethrin and piperonyl butoxide (PBO) REDs, and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on non-refillable containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.

Please note that the record for this product currently contains the Confidential Statements of Formulation (CSFs) listed below. Any previously dated CSFs are superseded.

A copy of your label stamped "Accepted" is enclosed along with copies of the acute

toxicity and product chemistry reviews completed for the subject product. Environmental Hazards

This product is extremely toxic to aquatic organisms including fish and invertebrates. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain do not blow or wash pesticide off the treatment area. Do not contaminate water when disposing of equipment, washwater or rinsate. See *Directions for Use* for additional precautions and requirements. This pesticide is highly toxic to bees exposed to direct treatment on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds while bees are actively visiting the treatment area.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Restrictions

Do not allow adults, children or pets to enter treated area until sprays have dried. Do not apply this product in a way that will contact adults, children or pets, either directly or through drift.

When used indoors: Remove pets, birds and cover fish aquariums before spraying. Do not remain in treated area; immediately exit area and remain outside the treatment area until aerosols, vapors and/or mists have dispersed. Do not enter or allow others to enter treated area until sprays have dried. Do not apply when food is present. Cover all food preparation surfaces and utensils during treatment or thoroughly wash before use. Do not apply as a broadcast or spot treatment to indoor surfaces in residential sites including nurseries, day care centers, schools, hospitals and nursing homes. Do not use in commercial food/feed handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not wet articles to the point of runoff or drip. Do not use treated article until spray has dried. **When used outdoors:** Do not apply during rain. Do not apply this product with a sponge. Do not wet plants to the point of runoff or drip. Do not water the treated area to the point of run-off. All outdoor applications must be limited to only spot or crack-and-crevice treatment, except for applications to soil/vegetation around structures and to building foundations (up to a maximum height of 3 feet). Other than applications to building foundations, all outdoor applications to impervious surfaces - sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors and eaves) are limited to only crack-and-crevice applications. Application is prohibited directly into sewers or drains or to any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Do not allow product to enter any drain during or after application.

Remove protective cap. [Affix trigger sprayer to bottle. Turn nozzle to on position.] [Use pump-up or other mechanical sprayer. Do not dilute this product.]. Point sprayer way from face and spray surface until slightly wet at a rate of 4 ounces product to treat approximately 25 square feet of surface area.

Indoors

Ants, Booklice, Boxelder Bugs, Centipedes, Cockroaches (including adult and immature stages of both non-resistant and organophosphate- & carbamate-resistant strains), Crickets, Dermestids, Firebrats, Fleas, Palmetto Bugs, Silverfish, Sowbugs, Ticks and Waterbugs: Thoroughly apply to all areas where these pests crawl and hide, especially in cracks and crevices; hidden areas around sinks and storage areas; behind baseboards; around doors and windows; behind and under refrigerators, cabinets, sinks and stoves; the underside of shelves; and drawers, bookcases and similar areas. When pests are driven out, spray directly.

Ants: Spray around ant trails, doors and windows where ants enter premises. Spray around nests hidden under steps, brickwork, concrete. Break apart accessible nests and spray on and around debris.

Brown Dog Ticks and Fleas: Apply in infested pet resting quarters; nearby cracks and crevices; under the edges of rugs and floor coverings; between and under cushions of upholstered furniture; and other areas where these pests may be present. Discard of pet's old bedding and replace with clean, fresh bedding after treatment of pet areas. **Do not use directly on pets.** Simultaneously treat pets with a flea and tick control product registered for use on pets prior to pet's entry into treated areas.

Carpenter Ants: For effective control, locate and treat nests and surrounding areas. Apply around doors and windows where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

Carpet Beetles (Black, Furniture and Varied): Spray on and under edges of floor coverings, under rugs and furniture and in closets or other locations where these insects are found.

Centipedes, Earwigs, Ground Beetles, Millipedes, Mole Crickets, Pillbugs, Scorpions, Sowbugs and Ticks: Apply around doors and windows where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

Pantry Pests: Cigarette Beetles, Chocolate Moths, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Flour Beetles (Confused and Red), Grain Beetles (Merchant, Rusty and Saw-toothed), Lesser Grain Borers, Rice Weevils, Spider Beetles and Tobacco Moths: Treat exposed stages. Remove all foodstuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray to shelves and in cracks & crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of shelf paper, food and utensils.

Spiders: Apply along and behind baseboards; to window and door frames; corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

Webbing Clothes Moths: Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

Outdoors

Point spray nozzle away from face. Hold container at a slight downward angle. For best results, spray when air is calm. Spray with the wind if a breeze is blowing. Do not water the treated area to the point of run-off. Do not make applications during rain.

Ants, Crickets, Earwigs, Fleas, Ticks (Dog and Lone Star): Thoroughly apply to infestation in bushes, grass or weeds. For ants, spray around ant trails and hills.

Crawling Insects: Ants, Centipedes, Cockroaches (including Asian cockroaches), Crickets and Silverfish: Spray infested surface of patio or picnic area, hitting as many insects as possible. Also spray legs of tables and chairs.

Pests on Outside Surfaces of Buildings: For control of building infestations of **Ants, Clover Mites, Crickets, Earwigs, Millipedes and Sowbugs (Pillbugs):** Spray foundation of building where insects are active and may find entrance up to a height of 3 feet. Apply as a residual spray to outside surfaces of buildings where insects tend to congregate. Spray areas include, but are not limited to, screens, window frames, eaves, porches, patios, garages and refuse dumps.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry (preferably locked) storage area away from children and pets. **Pesticide/Container Disposal:** Non-refillable container; do not reuse or refill this container. **If empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions.
