**KOCIDE 404S AGRICULTURAL FUNGICIDE**

**GENERAL INSTRUCTIONS**

KOCIDE 404S should be used as described below. KOCIDE 404S is adaptable to all types of spray equipment. For dilute, high volume sprays, use from 25 to 100 gallons per acre (GPA). For concentrate ground sprays, apply 5 to 20 GPA. For aerial spraying, 3 to 15 GPA are commonly used. No additional surfactants are needed.

Add KOCIDE 404S slowly to a spray tank partially filled with water. Sticker-spreaders, insecticides, nutrients, etc., should be added last. Because of the wide variety of possible combinations which can be encountered, observe all cautions and limitations on the label of all products used in mixtures.

The following specific instructions are based upon general applications. The recommendations of local Agricultural Experiment Stations should be closely followed as to timing, frequency and number of sprays per season.

**SPECIFIC INSTRUCTIONS**

**PEANUTS.** Begin spraying 40-45 days after planting or when disease symptoms appear. Make ground or aerial application at 1-2 quarts per acre depending upon disease severity. Continue applications at 10-14 day intervals or according to local recommendations. Use in sufficient water to get adequate coverage.

**CAUTION** - Avoid contact with skin and eyes. In case of skin contact, remove with washing. For eyes, wash with copious amounts of water and get immediate medical attention.

*This product is toxic to fish. Keep out of lakes, streams or ponds. Do not apply where runoff is likely to occur. Do not contaminate water by cleaning of equipment or by disposal of wastes.*
